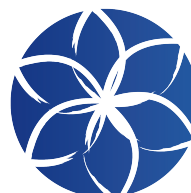

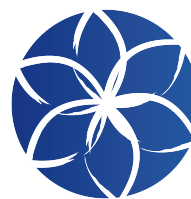

## Terms and regulations

1. The participant (being the applicant under the exhibit contract set out on the reserve of these terms and conditions) shall be bound by these terms and conditions, the rules and regulations as set out in the Exhibitor Manual and all other documents, which may be supplied, to the participant from time to time ('Terms and Regulations'). No variation to these terms and regulations or the rules and conditions is permitted other than where such variation is made in writing and is signed by an authorised employee of BureauSierteelt.nl B.V. The participant shall be deemed to act as agent in respect of each stand sharer who shall be bound by these terms and conditions and the rules and regulations as if they were the participant. Participants must notify BureauSierteelt.nl B.V. of any stand sharers.
2. All unusual promotion plans should be discussed and approved by BureauSierteelt.nl B.V. Only with approval of the organiser participants are allowed to carry out promotion outside of their rented space.
3. Participants are not allowed to dismantle their stand prior to the termination of the exhibition. Also participants will not be allowed to remove their exhibits and/or goods from the exhibition prior to the official termination of the exhibition.
4. The participant hereby acknowledges and agrees that none of BureauSierteelt.nl B.V. or its connected persons shall in any circumstances be held liable for any loss or damage incurred by the participant, its employees, agents or stand sharers not arising as a result of the fault negligence or omission of BureauSierteelt.nl B.V. or its connected persons.
5. The participant hereby indemnifies BureauSierteelt.nl B.V. in full in respect of any loss, damage, injury, liabilities or costs incurred by any of BureauSierteelt.nl B.V. or connected persons and in respect of any such claims made by a third party against BureauSierteelt.nl B.V. or its connected persons, which arise as a result of the fault, negligence or omission of the participant or its employees, agent, contractors, invitees or stand sharers.
6. BureauSierteelt.nl B.V., the publisher of the catalogue, the exhibit council, sponsors, its agents or employees will not be held responsible for any mistakes or omissions on copy prepared and submitted by the advertiser, advertising agency or participant.
7. The execution of the space application form and its receipt by BureauSierteelt.nl B.V. is conclusive and sufficient evidence of the participant's agreement to pay all costs related to their participation from that moment onwards. The participant cannot cancel the application. The participant is further aware that BureauSierteelt.nl B.V. has incurred costs as a result of the received space application form and is not obliged to refund and/or reimburse the participant for any of these fees which are agreed on the reverse side and BureauSierteelt.nl B.V. is also entitled to any unpaid amounts due by the participant to BureauSierteelt.nl B.V.
8. The rights of a participant cannot be transferred to another company or private person. The participant is not allowed to re-assign his space or sublet the whole or part of the space and/or stand to another company or person without prior approval of the organisers. The participant is aware that the floor plan is subject to change and has no right for any particular space. The requirements of the participants will be taken into consideration when spaces are being allocated.
9. No participant will be allowed to exhibit unless the full participation fees have been paid prior to the exhibition.
10. None of BureauSierteelt.nl B.V., its subsidiaries, employees, agents, sponsors or the Event Committee (its "Connected Persons") shall be liable for any loss, damage or delay resulting from acts of war, civil commotion, strikes or lockouts, shortage of labour, default or failure of suppliers, government action, intervention, law or regulation, military activity, act of God, fire, or any other circumstances beyond BureauSierteelt.nl B.V.'s reasonable control which shall make it impossible or inadvisable for the event to be held at all or at the scheduled time and place. BureauSierteelt.nl B.V. reserves the right (but is not obliged) to re-schedule the event at another date and/or at any alternative venue. The participant acknowledges that BureauSierteelt.nl B.V. will have sustained damage and loss as a result of the foregoing and hereby waives all claims for damages or compensation in respect of any act or omission of BureauSierteelt.nl B.V. or any of its connected persons as a result of any of the foregoing. In the event of force majeure, no refunds will be made and the monies paid to BureauSierteelt.nl B.V. as event fees or otherwise in connection with the event shall remain the property of BureauSierteelt.nl B.V.
11. BureauSierteelt.nl B.V. or its connected persons shall not be responsible for assisting the participant with obtaining a passport or a visa for entrance into the country where the exhibition is to be held. Should a participant fail to obtain these documents any monies payable in accordance with the exhibit contract shall remain owing in full.
12. The participant is not allowed to block the view of adjacent stands or in any other manner that would be unacceptable to other participants.
13. The initiator, BureauSierteelt.nl B.V., sponsors, its agents or employees are not responsible for any loss, damage or delay incurred in shipments into and out of the country where the exhibition is held. Participants are advised to insure their shipments.
14. The participant expressly acknowledges that no representations, guarantees or assurances – whether oral or writing – have been made or are to be implied or considered collateral to these terms and conditions (including, in particular but without limitation any statements relating to the potential business which may be generated by the exhibition). The participant further acknowledges that these terms and conditions and the accompanying exhibit contract constitute the entire agreement existing between the parties. Any previous agreement between the parties relating to the provision of exhibition space shall cease to have further effect. This agreement shall be governed by and construed according to Dutch Law. Any dispute between the parties under this agreement hereby submits to the exclusive jurisdiction of the Dutch Courts.
15. The exhibit council is not responsible for any loss due to cancellation, abandonment or postponement in whole or in part of the exhibition for causes beyond its control. Participant is advised to insure their participation expenses sufficiently in case of cancellation etc.
